I. PURPOSE

The aim of this MoU is primarily to collaborate to jointly conduct Intellectual Property and Technology Transfer related educational programs.

II. AREAS OF COLLABORATION/ STATEMENT OF WORK (SoW)

- i. Offering a fee paid program online or offline on above mentioned area in the Purpose
- ii. Giving participation certificates signed jointly
- iii. To jointly market/advertise the program

III. AGREEMENT FOR COLLABORATION

- i. i-TTO shall collaborate with NPC to serve as a knowledge partner with respect to Intellectual property (IP) and technology transfer (TT) educational programs and to jointly conduct educational programs on IP and TT for professionals, companies and small and medium enterprises.
- ii. i-TTO shall serve as the knowledge partner providing content, assist with the course development, finalization of curriculum and speakers/presenters for the modules.
- iii. i-TTO shall provide details of the webinars such as title, a brief abstract, speaker details, photo of the speaker as per the brochure format as shared by NPC.
- iv. NPC shall be responsible for providing the platform, course management and preparation of advertisement content, flyers/brochures.
- v. Both parties shall be free to announce this collaboration.

IV. NODAL AUTHORITY AND SIGNATORIES

The nodal officer and signatory from NPC shall be Secretary, NPC or any nominee and the nodal officer and signatory from i-TTO shall be Chief Manager, i-TTO or any nominee for all the decision making and concurrence.

V. IMPLEMENTATION AND ACTION PLAN

- i. Both parties agree to conduct weekly webinars or as decided mutually.
- ii. Both parties agree to share the fees received equally.
- iii. NPC shall be responsible for collecting the course fees and sharing it with i-TTO.
- iv. Both parties shall be free to announce this collaboration.
- v. Schedule for 3 weeks is shared as Annexure 1 and schedule for every 4 weeks will be shared prior hand.





VI. TENURE & TERMINATION

The MoU shall be effective from the date of signing and same shall remain in effect for 1 year and may be renewed or discontinued thereafter by mutual consent, giving notice of 30 days by either side.

VII. INTELLECTUAL PROPERTY

Neither party shall use the intellectual property, including logos, trademarks, service marks, trade names, service names, nor brand names of the other party, without obtaining prior written consent of such party.

VIII. DISPUTE RESOLUTION & CONFIDENTIALITY

Any dispute aside due to misunderstanding in relation to terms & conditions of MoU to be resolved amicably by the executants of the MoU without resorting to the court of law and /or by Head of the both parties. The decision of settlement of disputes arrived at shall be final and binding on both the parties. At the same time, utmost confidentiality to be maintained by both the parties during the validity of MoU.

IX. FORCE MAJEURE

Neither party shall be made responsible for an unexpected or uncontrollable event.


