NPC function through the following organs:

9.1 Council

9.1.1 Composition:

The Council regulates the policies of NPC. It has 30 members comprising the following:

- a) President, Chairman of the Governing Body and Director General, all nominated by the Government of India;
- b) 5 Representatives of the Government of India ;
- c) 5 representatives of the organizations of employers & Chambers of Commerce & Industry,
- d) 5 representatives of the organizations of National Trade Unions/Workers;
- e) 3 representatives of technical organizations and Institutions
- f) 3 representatives of Association of Local or regional or industry-wise productivity organizations which are recognized by the council for this purpose;
- g) 3 representatives from scholars, research workers, consultants, consumers, small and Services Companies (NASSCOM).
- h) 3 special invitees from emerging areas such as All India Council for Technical Education (AICTE), Indian Institute of Technology (IIT), Madras , Centre for Product Design and Manufacturing (CPDM), Indian Institute of Sciences (IISc), Bengaluru (Manufacturing 4.0 and IOT) .
