1. Graphic Designer / Digital Marketing Executive (One)

a. Job Responsibilities for Graphic Designer / Digital Marketing Executive

- iii. Ability to produce a wide variety of graphic products including catalog, brochures, pamphlets, etc.

b. Required skills

2. Content Writer (One)

a. Job Responsibilities

- ii. Editing & proofreading content with a zero- tolerance approach to grammatical errors, poor writing & plagiarism
- iii. Monitor & evaluate social media results & report regularly on performance & engagement across multiple social media platforms

Eligibility criteria:

- Qualification : Graduation/ Post Graduation relevant /equivalent to Job description
- Experience: 1 + year of Work Experience required
