In case if the same is found to be tempered/modified in any manner, tender will be completely rejected and EMD would be forfeited and tendered is liable to be banned from doing business with NPC.

- 1 The bidder should have its Head Office in Delhi or NCR.
- The Bidder will not be allowed to use lift for moving of the auction material.
- The firm should have an experience of at least 03 years in Government entities or Government organizations. Valid documents showing 03 years' experience in Government entities or Government organizations from the bidders are required
- 4 There should not been any disciplinary action against the firm.
- 5 The bidder should not have been blacklisted.
- All Bids must be accompanied by an EMD (Earnest Money Deposit) / Bid Security of amount of Rs. 10,000/- (Rupees Ten Thousands only), in the Demand Draft of in favour of **National Productivity Council, New Delhi** The bid security will be refunded to the unsuccessful bidders without any interest.

- 12. The bids will be opened at 11.00 pm on 08.01.2024.
- 13. The entire obsolete/unserviceable goods are to be disposed off on "AS IS WHERE BASIS" and there is in guarantee/warrantee whatso ever.
- 14.Sale of obsolete/unserviceable/material/scrap goods shall be awarded to the highest responsive bidder.
- 15. The Reserve Price for the BID is Rs.3.85 lakh (Rupees Three lakh Eighty Five thousand only) and Bids below the amount will be treated as non-responsive and rejected.
- 16.In case the highest bidder fails to deposit the full amount as per award of tender less the EMD deposited within 3 days or fail to lift the goods within 15 days (from the date of award of bid) after depositing the amount , the offer shall be cancelled and the Earnest Money Deposit shall be forfeited. The defaulting bidder shall have no claim/right in respect of property/amount.
- 17.Successful bidder will have to arrange labour for dismantling the machinery, lifting, loading/unloading etc. and the scrap shall be lifted from the present location at the cost of the bidder.
- 18.Tax liability, if any shall be borne by the successful bidder.
