NPC notified as implementing agency under PMMSY

The National Productivity Council (NPC) has been notified as one of End Implementing Agencies under the Pradhan Mantri Matsya Sampada Yojna (PMMSY) umbrella scheme of the Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying, Government of India. The PMMSY has been approved at a total estimated budget cost of Rs. 20,050 crore and aims to bring about blue revolution through sustainable and responsible development of the fisheries sector in India. The PMMSY will be implemented in all the states and UTs for a period of five years from Financial Year 2020-21 to 2024-25.

The NPC has been entrusted to carry out a study on, 'Baseline Survey on Production and Productivity of Inland Fisheries in India' under PMMSY. The study would be conducted in 14 major states of the country producing substantial inland fisheries and would be completed in nine months period. More studies under PMMSY would be awarded to the NPC by the department.


PRoductivity Integrated Monitoring & Evaluation (PRIME)




