3. LEARNING OBJECTIVES

This program equips all participants with adequate knowledge on security vulnerabilities and countermeasures associated with modern information systems, along with important concepts related to the IT infrastructure landscape, networking fundamentals, cloud computing & Industry 4.0 technologies, and different types of IT architectures that are fundamental to understand different types, and areas of cyber threats, and how to secure the IT systems. Further, the workshop covers best practices, with industry examples, including governance and design principles for a secure IT ecosystem.

- ❖ Introduction to cyber security, information security vs cyber security, an overview of Cyber threats the evolution of cyber security domain, timeline of major attacks, global trends, key initiatives of the Government of India

- ❖ Networking concepts, topologies, IP address, Protocols, packet relaying, Internet, Dark Web
- ❖ Understanding the Types of Threats
- ❖ Advanced cyber-attacks – injection, cross-site scripting, Advanced persistent threats (APT), DNS Poisoning, Sniffing, Metasploit, logic bomb, TCP I/P hijacking
- ❖ History of security systems,
- ❖ Encryption – Decryption algorithm – Real-life classroom example
- ❖ Data protection concepts

5. METHODOLOGY

The methodology of the training program would be participative in nature. The sessions would be based on conceptual deliberations, case studies, success stories and group exercises/discussions.

All employees across middle & Senior management levels (Non-IT Professionals) working in Ministries, Central & State PSUs, Central & State Government Departments and other manufacturing and process industries.
