COURSE FEE

The course fee is **Rs. 15,000/- + GST @18% (i.e. Rs. 17,700/- (Rupees Seventeen Thousand and Seven Hundred only))** per participant for all the above four papers. The course is non-residential. Candidates who would wish to attend for only selective papers are required to pay **Rs. 3750/- + GST @ 18% (i.e. Rs. 4,425/- (Rupees Four Thousand Four Hundred and Twenty-Five only))** per paper.

Residential accommodation on first-come-first-served basis is available at NPC, Chennai (Optional): Single room A/c @ Rs. 1,800/- per day + GST (@12%. The accommodation charges may be paid in advance by NEFT Transfer or by cash at the time of check out.
