## **1. ABOUT NPC**

The process of economic growth and development is a dynamic process engaging the various agencies and stakeholders from citizens to industry to enterprises across the product manufacturing and services provisioning components and the supply chain and the role of public sector and private sector and institutions and the government are significant and fairly demarcated. Yet there are deep interlinkages and two way and multidirectional processes pertaining to innovations in products and services provisioned and the diffusion across the demographic and geographic terrain that get guided by the policy frameworks and decision-making processes in the various regimes and democracies having their own varieties of institutionalised components that generate initiative and implement action across thematic areas and disciplines. A good bureaucratic framework and private sector organization and ecosystem play pivotal role in the progress and forward movement and the coordination and cooperation within the institutionalised architecture becomes crucial and accordingly policies, vision, missions in public and private sector and government and related entrepreneurship leadership in conceptualising strengthening and implementation of the resource allocation as well as autonomous resources flow occur and the output and outcomes of economics and development activity get created and distributed. The importance of policy entrepreneurship, policy making and program design and project implementation action alongside project steering and monitoring and evaluation across Ministries and economic sectors.

## **3. LEARNING OBJECTIVES**

- The training programme seeks to and enables a deep dive into the exciting and very important policy prototyping domain and policy making process and program conceptualisation and design processes for projects development and implementation.

- It opens a larger canvas for learning and deliberations on a spectrum of thematic areas and brings together a wide range of experiences not only from the faculty but also of the practitioners from the bureaucracy and various services and institutionalists as well as senior officials from public and private enterprises and civil society
- It brings actual case examples and insights building case exercises & of policy making, guidelines development etc and M&E activities and project implementation experiences. The coverage shall span the broad sector of manufacturing, agriculture services and science and technology and domain of infrastructure development and the public goods provisioning landscape and reflect on the urban and rural development domain and multilevel governance feature, besides the planning project implementation and monitoring and evaluation application and shall employ tools and application as well as address various notified rules/ acts and provisions and reflect on achievements and a way forward oriented policy roadmaps.

#### **4. BROAD PROGRAMME COVERAGE**

The following key topics shall be covered during the training programme along with indicated subcomponents.

##### 1. Economy and Political History related insight

Addressing economic growth and development constructs including micro and macroeconomics and their features. Additionally the evolution of economic thought and development initiatives.

##### 2. Policy needs and policy prototyping focusing on innovations in Policy entrepreneurship and program design.

This session to cover aspects of policy studies and approach to policy prototyping. Further exploring multi-level governance, gap analysis, field studies pertaining to programmes/scheme/projects and data collation and reviews for insights. Towards policy entrepreneurship and design articulation of vision and mission and formulation of guidelines and their review and exercise in guidelines evolution and outlining of implementation & review mechanism.

##### 3. Emergence & impetus on science and engineering

Evolution of science/scientific thought and revolutions and paradigm shifts related features of agriculture, Manufacturing & service sectors. A need for machine design and need for product mapping and technology mapping and methodology development process with broad parameters & Sub parameters etc along with case exercises.

##### 4. Industrial revolution and evolution

Insights into Indian and international industrial development process and the nature and range of cluster types. Perspectives on the cluster approach and dynamics aspects

of competitive advantage and comparative advantage revisit, scenarios observed about industrial cluster and experience sharing and the PLI scheme features etc.

#### 5. Industrial parks, zones, and cluster rating

A perspective on industrial park rating and ranking scheme and a focus on industrial cluster rating methodology as an exercise and its strengthening and the prospects of products mapping and material flow analysis.

#### 6. Natural resources management and the environmental movement and call for sustainability problems and indicators of pollution.

The emergence of environment and the movement and readings in domain of public goods and provisioning. Environmental impact assessments to post environmental clearances monitoring and need and approach to environmental services and environmental auditing. The emergence of sustainability reporting and Business Responsibility and sustainability reporting and insights of environmental stewardship.

#### 7. The domain of waste management and insight into 6 waste management rules and circular economy

A focus on the key rules on waste management and roles and responsibilities and insights on the progress of implementation and response specially solid waste management, biomedical waste management, plastic waste management and the emphasis of resource conservation and scientific waste management initiatives for circular economy and significance of product composition declaration and circular economy techniques.

#### 8. The programme on waste minimisation and features of WMC projects.

Programmes and contribution leading to group consulting action and enabling lean manufacturing cluster project. Insights on and project communication and regarding significance and approaches to project branding and multiplier effects.

#### 9. Institution and institutional development and institutional organization features

The Indian institutional framework and the significance of institutional system and of institutional will and mandates SWOT in institutional functioning and ideas of governance efficiencies. Aspect of institutional evaluation potential approach to institutional redesign and evolution with case explorations.

#### 10. The importance of concurrent M&E and Project steering

A focus on M&E and evolving framework on monitoring and evaluation of programme/schemes and projects and the approaches including concurrent M&E and impact assessments, Case studies in M&E initiatives and key learnings and exercise in strengthening M&E initiatives with productivity indicators.

#### 11. Addressing future policy prototyping prospects

The key features of policy prototyping and policy formulation in programme design and case(s) of institutional establishment and their functioning/ achievements etc and

gaps and prospect for new institutions to be established and exercise in the structuring of institutional frameworks for programme projects implementation.

## 12. Policy formulation case study

Case exercise on the emergence of an environmental notification and related stakeholder consultations, policy formulation and associating framework for implementation for component structuring.

## 13. Urbanisation and urban Development and rural development.

Attention to urbanisation theory, municipal bonds, urban management, a focus on sustainable transport, swachh sarvekshan and area of smart city programme and rating ideology. The scenario on rural development and ongoing initiatives. A revisit to constitutional amendments 73<sup>rd</sup> and 74<sup>th</sup>. Rural development and Panchayati Raj and the initiative.
