

1. ABOUT NPC

National Productivity Council (NPC), an autonomous organization established in the year 1958, under the Department for Promotion of Industry and Internal Trade, Ministry of Commerce & Industry, Government of India, is a pioneering institution providing consultancy, training and audit services in various disciplines to promote productivity culture in the country.

Dr. Ambedkar Institute of Productivity (AIP), a training wing of NPC is engaged in training Consultants for in-house needs and Executives from Industry, Government, PSU's and Private Organizations on a sponsored or self- financing basis. Further AIP, NPC, Chennai is the Nodal Agency for organizing and conducting the National Certification Examination for Energy Managers and Energy Auditors on behalf of the Bureau of Energy Efficiency, whereby about 20,000 Certified Energy Auditors/Managers serve the Indian economy today.

NPC has set up the Centre of Excellence for Training in Energy Efficiency Training (CETEE) at AIP, Chennai. The CETEE facility is the culmination of Indo-Japanese Governmental cooperation and has been implemented with the help of Bureau of Energy Efficiency (BEE), Government of India, and New Energy Development Organization (NEDO) and Sumikin Management Company, an associate of Sumitomo Steels, Japan.

CETEE is equipped with various industrial energy utility equipment designed to demonstrate practically, various aspects of energy efficiency practices and conservation techniques as applicable in industries. CETEE has been providing world class training to public sector companies (ONGC, IOCL, GAIL, PCRA, BHEL, Power Grid etc.), corporate companies in private sector as well as international organizations (UNEP, APO, UNIDO, GIZ, ITEC) since its inception.

The training has been designed considering the need to strengthen energy auditing expertise among the energy professionals to meet the growing demand of the industries. The approach for energy auditing for various utility systems will be clearly explained, by experienced faculty, starting from the first principles to include things like what data to collect, what to look for during field audit, how to analyse data, and how to report the findings.
