# 1. ABOUT NPC

A good bureaucratic framework and private sector organization and ecosystem play pivotal role in the progress and forward movement and the coordination and cooperation within the institutionalised architecture becomes crucial and accordingly policies, vision, missions in public and private sector and government and related entrepreneurship leadership in conceptualising strengthening and implementation of the resource allocation as well as autonomous resources flow occur and the output and outcomes of economics and development activity get created and distributed. The importance of policy entrepreneurship, policy making and program design and project implementation action alongside project steering and monitoring and evaluation across Ministries and economic sectors play key role in the economic growth and development process.

This residential training programme makes a fresh foray into the various dimensions of policy entrepreneurship and program design and project /schemes implementation and M&E process in the national and regional (urban, rural) development context and seeks to add value to the policymaker and programmes, scheme /project designers and implementors by the sharing of the various case studies in the menu of policy and programme initiative and engagement in a series of case exercises for hands on collective experience across thematic and subject areas as reflected further in the brochure section 4.0.

### 3. LEARNING OBJECTIVES

- The training programme highlights Policy Entrepreneurship, Policy and Program evaluations and design processes for project development and implementation.
- It opens a larger canvas for learning and deliberations on a spectrum of thematic areas / sectors and sub-sectors and brings together specialists and practitioners from various cadres among faculty and participants as well as from public and private enterprises
- In this programme we will examine multilevel governance, project planning, sectoral policy evolution and programme development and Monitoring & Evaluation. It brings actual case examples and insights building case exercises & of policy making, guidelines development etc and M&E activities and project implementation experiences. The coverage shall span the broad sectors of manufacturing, agriculture services and science and technology and domain of infrastructure development and the public goods provisioning landscape and reflect on the urban and rural development aspects as well as address various notified rules/ acts and provisions and reflect on achievements and a way forward oriented policy roadmaps.

### 4. BROAD PROGRAMME COVERAGE

The following key topics shall be covered during the training programme along with indicated sub components.

1. Policy Entrepreneurship, program design and political psychology

In this session we shall highlight features of policy entrepreneurship and political psychology and the applications. Further, this session to cover aspects such as multi level governance, gap analysis, stakeholder analysis, corporatist interest groups. The insights on field explorations pertaining to programmes/scheme/projects and data collation and reviews for insights. Finally, participant discussions on policy entrepreneurship and design and review of articulation of vision and mission and formulation of guidelines and their review and exercise in guidelines evolution and outlining of implementation & review mechanism.

2. Economic growth and development ethic.

Addressing economic growth and development constructs including micro, macro and international economics and aspects of firms and organisations and aspects of competitive advantage / comparative advantage features.

# 3. Science and Technology

History of science/scientific revolutions and paradigm shifts related features of Manufacturing sector and Emerging industry 4.0 and 5.0. A need for machine design and need for product mapping and technology mapping and methodology development process with broad parameters & Sub parameters etc.

# 4. Industrial organization and development

Coverage includes insights into Indian and international industrial development process and the nature and range of cluster types. Perspectives on the cluster approach and dynamics aspects of competitive advantage and comparative advantage revisit, scenarios observed about industrial cluster and experience sharing and the PLI scheme features etc. A perspective on industrial park rating scheme and a focus on industrial cluster rating methodology as an exercise and its strengthening and the prospects of products mapping and material flow analysis.

# 5 The environmental and sustainability focus

The emergence of environmental concerns and the movement and readings in domain of public goods and provisioning. Environmental impact assessments to post environmental clearances monitoring and need and approach to environmental services and environmental auditing. The emergence of Business Responsibility and sustainability reporting and insights of environmental stewardship.

6. The domain of waste management and minimisation and insights into a set of waste management rules.

A focus on a set of waste management rules and roles and responsibilities and insights on the progress of implementation and response specially solid waste management, biomedical waste management, plastic waste management and the emphasis of resource conservation and scientific waste management initiatives. A visit to Swachh Survekshan / Smart city aspects.

7. The programme on waste minimisation and features of WMC project.

A view of Programmes and contribution leading to group consulting action and enabling lean manufacturing cluster project. Insights on and project communication and regarding significance and approaches to project branding and multiplier effects.

8. Institution and institutional development and institutional organization features

The Indian institutional framework and the significance of institutional system and of institutional will and mandates An Evaluation framework for an institution (case exercise) and of institutional functioning and ideas of governance efficiencies. Aspect of institutional evaluation potential approach to institutional redesign and evolution with case explorations and a visit to case of NCPC.

#### 9. Program and scheme impact assessment and concurrent M&E

Exploration of sectoral policy evolution (Health or Transport etc.). Further, the M&E focus and evolving framework on monitoring and evaluation of programme/ schemes and projects and the approaches including concurrent M&E and impact assessments case studies in M&E initiatives and key learnings and exercise in strengthening M&E initiatives with productivity indicators.

# 11. Evolving future policy entrepreneurship prospects

Reflections towards evolving features of policy entrepreneurship and policy formulation in programme design and prospects in the context of HRD / Skill Development and/or related jobs/employment domain and of institutional participation as well as institutional establishment and their functioning/achievements etc and gaps and prospect for new institutions to establish.

# 12. The emergence of and the need for circular economy

The nature of project to develop for circular economy and exercise on techniques for enabling circular economy to succeed. Case of end-of-life recycling such as automobile sector etc. The context and essence and significance of circular economy with focus on Product composition declaration related needs and significance.

13. Urban Development and rural and spatial economy.

Attention to urbanisation theory, and urban management issues and a focus on aspects of smart city programme and rating ideology. The scenario on rural development and ongoing initiatives. A revisit to constitutional amendments  $73^{\rm rd}$  and  $74^{\rm th}$  and regarding Rural development and Panchayati Raj.

14. Closing session and certificate distribution & feedback.

#### 5. TARGET PARTICIPANTS

Senior and middle level officials and members of Government cadres from centre and statse and across services and officials from various institutions / autonomous bodies and public and private sector organizations and international organisations. Further from a range of departments, sectoral institution as well as research centres that would enable confluence of various domains of services as well as multiple disciplines and experiences converge for a collective effort at various policy and project explorations and to address policy implication and achievements and scope for new policy design.
