1. ABOUT NPC

National Productivity Council (NPC) is an autonomous organization under the Department of Promotion of Industry and Internal Trade, Ministry of Commerce & Industry, Government of India. The present expertise available in NPC has a resource base of professionals from fields such as Economics, Industrial Engineering, Human Resource Management, Energy, Environment, IT, Project Monitoring and Evaluation, Research Studies and Baseline Surveys. In addition, services of external professionals and subject matter specialists are also sought on need basis, depending upon the nature and scope of work. 2. PROGRAMME THEME

In the year 2016, Ministry of Environment Forest & Climate Change, Govt. of India has introduced 6 Waste Management rules (plastic waste management rules, solid waste management rules, hazardous waste management rules, e-waste management rules, biomedical waste management rules, construction and demolition waste management rules). As per an assessment released by Press Information Bureau (PIB), GOI, dt. 5th April, 2016, around 62 million tonnes of solid waste is generated annually out of which 5.6 million tonnes is plastic waste, 0.17 million tonnes is biomedical waste, hazardous waste generation is 7.90 million tonnes per annum and 15 lakh tonne is e-waste. India is among the top 10 countries in the world generating the highest amount of municipal solid waste, and the bigger problem is that approximately 70-75% of this waste remains untreated. This untreated waste of 31 million is mostly dumped into landfills. The country generates an estimated 150 million tonnes of C&D waste every year, according to the Building Material Promotion Council. The scope of Circular Economy and its potential is indicative in the above context as well as in the context of potential sectors and business models that can emerge and deliberated.

3. LEARNING OBJECTIVES

This training program prepares participants to:

1. To build capacity of stakeholders using lectures, audio visual aids and through discussions.
2. To reflect on Circular Economy as a concept to progress beyond the idea and scenario of linear economy.
3. To highlight emergent business models promoting circular economy.

4. To draw emphasis on roles and duties of various stakeholders, standards for treating and disposal of wastes, reporting requirements and other elements as given in waste management rules, 2016 and their amendments thereof and regarding business and innovative initiatives that are emerging towards enabling Circular Economy related objectives.
5. To understand the scientific waste management process through specific case studies presentation and deliberations and reflect on national and international Circular Economy examples.
6. To provide insight into various aspects, issues, challenges faced by officials of Corporations, Municipalities & Panchayats, etc and identifying solutions relating to waste management in terms of planning & assessment, generation, segregation, storage, transportation, treatment and scientific disposal, etc. Further, to explore the barriers and enablers for business enterprises to engage in pro active Circular Economy solutions.
7. Undertake a field visit to a Waste Management facility & understand mechanism that facilitate or hinder Circular Economy initiatives.

4. BROAD PROGRAMME COVERAGE

The following topics shall be covered during the training

- a. Circular Economy as a concept and its features
- b. Some baseline indicators & problems of pollutions w.r.t air, water, land.
- c. Exploring business models concerning circular economy.
- d. Key provisions of SWM Rules,2016 and implementation issues and challenges
- e. E-Waste Management Rules 2016 and its subsequent Amendments
- f. Key provisions of Bio-Medical Waste Management Rules, 2016 with recent amendments and Implementation issues & challenges
- g. Key provisions of Plastic Waste Management Rules, 2016 and implementation issues and challenges
- h. Key provisions and Salient features of Construction & Demolition Waste Management Rules, 2016, and Best Practices of C&D Waste Management
- i. Case studies, examples and success stories in emergence of Circular Economy momentum, perception and related model and their advantages in the evolving socio-economic system

5. METHODOLOGY

Methodology of the training program would be participative in nature. The sessions would be based on conceptual deliberations, case studies, success stories and group exercises/discussions.
