About Programme: - In the year 2016, Ministry of Environment Forest & Climate Change (MoEF & CC), Government of India has notified Six Waste Management Rules (Solid Waste Management Rules, Plastic Waste Management Rules, Hazardous Waste Management Rules, E-Waste Management Rules, Biomedical Waste Management Rules, Construction & Demolition Waste Management Rules). As per the rules, the timeframe for completely adoption of these rules by the stakeholders is about 1 to 2 years. In this regard, to strengthen the duties and responsibilities of applicable stakeholders/authorities with respect to scientific management of waste. NPC, Bhubaneswar has designed this online training programme on “Six Waste Management Rules, 2016” to enhance capacity and awareness of stakeholders involved in management of Waste.

Objectives: -This online training programme has been designed with the objective to enhance the understanding of waste management rules and to build capacity of all stakeholders. This will be achieved by a regular training and providing them with adequate knowledge to implement these rules in an effective way so that we can contribute to effective handling and management of waste.
