Financial institutions providing project finance are placing greater emphasis on substantive implementation of applicable sustainability frameworks including IFC Performance Standards and the Equator Principles. Greater attention is paid to the rights of indigenous peoples and human rights in general, and governance structures are gaining in prominence; sponsors are responding with more detailed identification and mitigation of environmental and social impacts throughout the lifetime of their projects.
