NOTICE FOR EMPANELEMNT

Whereas the Central Pollution Control Board (CPCB), vide Office Order dated 20 September 2025 to NPC, has issued the Standard Operating Procedure (SOP) for the Empanelment of Original Equipment Manufacturers (OEMs) of Air Pollution Control Devices (APCDs).

Now, therefore, the National Productivity Council (NPC), in pursuance of the said Office Order and the aforesaid SOP, hereby **invites applications for empanelment** from eligible OEMs of APCDs for installation/upgradation in industrial units in the National Capital Region (Delhi–NCR).

The scope of empanelment shall cover, inter alia, Electrostatic Precipitators (ESPs), Bag Filters, Cyclones, Wet and Dry Scrubbers, Fume Extraction System and other recognised categories of industrial APCDs.

Eligibility

- Entities duly incorporated and registered in India with valid GST registration, Permanent Account Number (PAN) and Consent-to-Operate from the competent Pollution Control Authority, if applicable; and
- Minimum 3 years of experience in the design, manufacturing, supply, and installation of APCDs, with at least five (5) operational installations in the applied category within the last 3 years in India.
- For more information, please check the application form.

Application

- The application window shall remain **open on a continuous basis**.
- **Offline Mode:** Until commencement of the online submission facility, applications may be submitted in hard copy or through e-mail with all requisite enclosures and proof of fee payment at the office of the National Productivity Council, New Delhi, by speed post/hand delivery/registered post/courier and also via email. - **Online Mode:** Once the online facility is operational, applications shall thereafter be submitted **exclusively** through the NPC website (www.npcindia.gov.in).

- Applications must be in the **prescribed form**, accompanied by all supporting documents and the non-refundable fees specified in the SOP.
- Concessions in fees, where eligible, shall be available to Micro and Small Enterprises (MSEs), Local Suppliers and Start-ups in accordance with Government of India guidelines.

1. Only Original Equipment Manufacturers (OEMs) shall be eligible for empanelment.
2. The OEM shall be a Proprietary Concern, Private Limited Company, Limited Company or Public Sector Undertaking (PSU), duly incorporated and registered in India under the applicable laws, and shall hold a valid Certificate of Incorporation/Company Registration.
3. The OEM shall have been engaged in the business of manufacture and supply of Air Pollution Control Devices (APCDs) for a minimum period of Three (3) years within India.
4. The OEM shall possess a valid Goods and Services Tax (GST) Registration.
5. The applicant shall be liable to pay the following fees, ***GST additional (@18%):—***
 - (a) Application Processing Fee – ₹25,000/- (Rupees Twenty Five Thousand only), one-time and non-refundable, payable at the time of initial application;
 - (b) Empanelment Fee – ₹65,000/- (Rupees Sixty Five Thousand only) per APCD model type, payable at the time of submission of the empanelment application;
 - (c) Field Verification Fee – ₹57,000/- (Rupees Fifty Seven Thousand only), payable as and when as and when field verification is required for empanelment. (Note: Emission Testing Fees shall be charged additionally, on actuals and Airfare on actuals if any).
 - (d) **Annual Renewal Fee** – ₹35,000/- (Rupees Thirty-Five Thousand only), payable at least 60 days prior to the expiry of empanelment validity for renewal of empanelment.

7. The empanelment granted shall remain valid for the period of validity of the corresponding product certifications, provided that the OEM shall renew such empanelment annually by remitting the prescribed Annual Renewal Fee.
 8. During evaluation, the NPC or the Central Pollution Control Board (CPCB) may seek clarifications or call for additional documents, which shall be furnished within the time limit stipulated by NPC/CPCB.
 - During empanelment, a field verification of installations for performance evaluation shall be carried out by NPC, and the prescribed Field Verification Fee shall be paid by the OEM prior to such visit.
 - Additionally, surveillance visits of the OEM's installations may be conducted as and when required. The related charges shall be borne by the OEM and paid to NPC upon prior intimation.
 9. OEMs found qualified shall be empanelled and notified. Upon empanelment, a User Name and Password shall be issued for uploading product details on the designated portal, which shall be subject to verification, approval and publication.
 10. The applicant shall furnish a declaration affirming that all information and documents submitted are true and correct. Any misrepresentation of facts or submission of false or forged documents shall entail rejection of the application and blacklisting of the applicant.
 11. The OEM shall furnish, in respect of each APCD proposed for empanelment, the technical brochure, General Arrangement (GA) drawing, process flow diagram and design specifications.
 12. The OEM shall furnish guaranteed performance parameters including, inter alia, pollutant removal efficiency (for PM10, PM2.5, SOx, Nox, etc), outlet emission concentrations and pressure drop across the device, supported by field data or test reports.
 13. The OEM shall submit details of major installations completed in the last three (3) years (minimum five), specifying the client, location, type of APCD supplied, design capacity, and year of commissioning.

14. The OEM shall provide information on Operation & Maintenance (O&M) requirements, including details of manpower, consumables, critical spare parts and recommended maintenance schedule.
15. The OEM shall ensure that the design and performance of the APCD comply with the emission standards prescribed by the Central Pollution Control Board (CPCB) and the relevant ISO standards for the concerned industry or process.
16. The OEM shall furnish an undertaking to provide after-sales service support and to ensure availability of spare parts for a period of not less than five years from the date of supply or installation.
